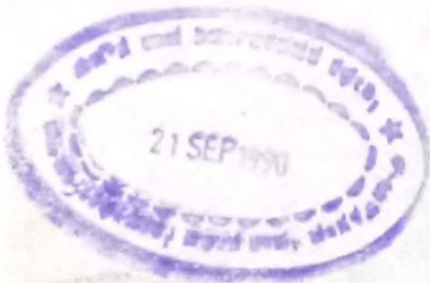

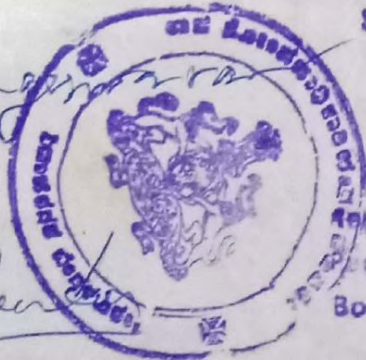

Who hereinafter collectively called as the "BOARD OF TRUSTEES" or "THE BOARD" and the member of the Board shall mean and include not only the first member of the Board but also other members who are appointed and/or nominated or co-opted as provided infra and Board of Trustees constituted from time to time.

WHEREAS the Board of Trustees representing "MARUTHI VIDYA TRUST" in furtherance of the said objects have contributed at the rate of Rs.101/- (RUPEES ONE HUNDRED ONE ONLY) each and declared a sum of Rs.707/- (RUPEES SEVEN HUNDRED SEVEN ONLY) as the Trust Property and delivered the same to the Board of Trustees, the receipt of which the Trustees hereby acknowledge, to have and to hold the same upon TRUST as and from the date of execution of this Trust Deed and have also agreed to administer the said property subject to the terms and conditions declared and contained in these presents.

WITNESSETH AS FOLLOWS

WHEREAS Trustees B.S.Rajagopalan and Smt.Saroja Ganesh above named are president and secretary respectively of the Managing Committee of the society known as "MARUTHI VIDYA SANGHA" having its office at Subbayana Palya, Bangalore - 43, which has been duly registered under the provisions of the Karnataka Societies Registration Act, and Rules made thereunder with the Registrar of Societies, Bangalore City Area, Bangalore, under Certificate of Registration bearing No.50 dated August 29, 1978; and

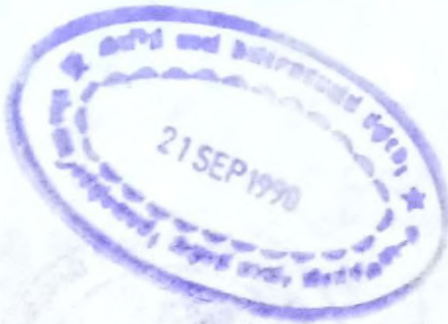

WHEREAS the Trustees are desirous of creating a Trust in respect of Educational Institutions run by the Society under the name and style of "MARUTHI VIDYA TRUST" at Subbayna Palya, Bangalore - 43 or at such place or places deemed suitable by the Board of Trustees from time to time, with the object of making proper and adequate provision for the efficient management of the Educational Institutions run by it and to promote its growth into a good Educational Central on combined state and Central Government curriculum in Nursery, Primary, Secondary, Higher Secondary, Post-Matriculate levels and for purposes of starting Technical Training Institutes, Teacher Training Institutes etc., and

WHEREAS in pursuance of the decision of the General Body of the Members of the Society had at the Special General Meeting of the Society held on 27.9.90 to dissolve the "MARUTHI VIDYA SANGHA" and to create a Trust in respect of the aforesaid Educational Institutions run by it, the Trustees herein combine and constitute themselves as Board of Trustees of the Trust called "MARUTHI VIDYA TRUST" (hereinafter referred to for short as the TRUST).

NOW THIS DEED WITNESSETH AS FOLLOWS

1. In pursuance of the decision of the Special General Body Meeting of the Members of the "MARUTHI VIDYA SANGHA" at their meeting held on 27.9.90 the Settlers hereby convey, transfer and assign to the Trustees the Management of the "MARUTHI VIDYA TRUST" Bangalore - 43, along with the Educational Institutions run by it under the name and style of "MARUTHI VIDYALAYA" to hold the same to the Trustees upon the Trust with and subject to the powers, provisions and agreements hereinafter declared and expressed

concerning the same with the object of making proper and adequate provisions for the efficient management of the Educational Institutions and to promote its growth into a good educational centre for starting Training Institutes etc.

2. The name of the Trust created under this shall be known as "MARUTHI VIDYA TRUST". The central office of the trust shall be situated at Subbainapalya, Banasavadi Main Road, Bangalore - 43 and/or at such place/s as the Board of Trustees may decide from time to time.
3. The objects of the Trust shall be, as follows:
  - a) to start educational institutions at nursery, primary, secondary, higher secondary, post-matriculate levels and for purposes of starting technical training institutes, teacher training institutes etc.
  - b) to open professional colleges, technical institutions, training institute for nursery, primary and high school teachers in the state of Karnataka;
  - c) To open and run an efficient library and reading rooms for the student community;
  - d) To encourage fine arts i.e. music, dance and drama to endeavour to preserve and promote our ancient culture;
  - e) to encourage sports activities;
  - f) to open Hostel for School-going students;
  - g) to acquire movable and immovable properties for the use of the Trust; and
  - h) to do such other things as are necessary and conducive to the promotion of education and knowledge.

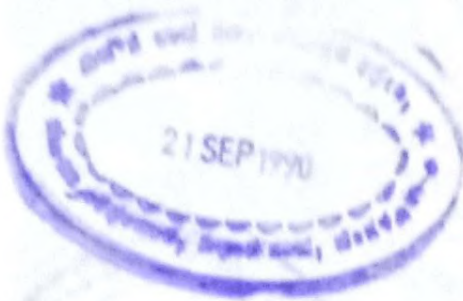

The Trustees shall bind themselves or through Managing Committee of Trustees appointed by them, to manage and deal with the above mentioned Educational Institutions in such a manner as may be most beneficial for the growth of the Institutions and shall be responsible for the income accruing from the Institutions and shall do every such thing as may be legally necessary for the maintenance and proper functioning of the educational institutions.
5. Sri.B.S.Rajagopal, the Trustee shall be herein the President of the Board of Trustees. He shall be the Chairman of all the Managing Committees constituted by the Board of Trustees to run and supervise the different activities of the Trust and Chairman of all the Meetings of the Board of Trust.
6. Smt.Saroja Ganesh, Trustee herein shall be the Secretary of the Board of Trustees. She shall be the Hon.Secretary of the Managing Committees constituted by the Board of Trustees to run and supervise the different activities of the Trust. She shall also be the Principal of the Educational centres run by the Trust. The Secretary shall look after the administration and day to day management of the trust. The Secretary shall individually operate the Bank accounts of the Trust.
